Following the decision of GPHR to take on board the rugs for the 2YO and 3YO Westbred Classics, it was agreed that a rug and garland would be provided this year for this race, along with the trophy.

3 Standing Item – Fillies and Mares Racing

Suggestions/comments for discussion with the Harness Office include:

- double concessions (mare and junior)
- preferential draw (fillies/mares/juniors)
- Heat opportunities (such as John Higgins, subsequent wins don't penalise eligibility for final)
- adjustment of \$L5 conditions to enable metro horses to start in midweek races
- Accumulating points in race series
- Issues around having adverse barrier draws when dropping back in class

1. ASBA General Meeting 26 June 2022

J Diederich reported that the meeting was quite productive:

- An updated Constitution was approved to permit teleconferences, proxies and appointment of specialists.
- J Coffey was appointed as a breeding expert to assist ASBA, and Tony Britt has been appointed as a Biosecurity and Welfare consultant.
- Issues need to be resolved with HRA moving forward.
- Victoria is currently the only state that undertakes freeze branding
- USTA has a phone app to interact with microchips and the US database to enable easier identification of horses.
- The 2023 Sales will be the first sales where yearlings are not microchipped. Lack of freezebranding has not had an impact on the Sales as yet.
- Request HRA treat mares the same as trotters with respect to Group racing levels.
- T Britt reported on action of activists with the thoroughbred code.
