#### 3 Standing Item – Fillies and Mares Racing

J Diederich reported that this has yet to be progressed, but a recent change to the rules relating to drop backs (horses using novice driver concessions in selected races will draw in accordance with the level that he/she drops back to, rather than retaining the actual level) that commenced on 2 September, should assist some horses.

Suggestions/comments for discussion with the Harness Office remaining are:

- double concessions (mare and junior)
- preferential draw (fillies/mares/juniors)
- Heat opportunities (such as John Higgins, subsequent wins don't penalise eligibility for final)
- adjustment of \$L5 conditions to enable metro horses to start in midweek races
- Accumulating points in race series
- Issues around having adverse barrier draws when dropping back in class

Some options to be developed for horses that are not progressing, and improved racing opportunities for juveniles.

J Diederich noted that some trainers are now becoming involved with breeding from mares raced by their stable clients, and this was a good outcome that should be encouraged.

Committee discussed the lack of commitment from RWWA to promote and support the breeding industry in WA, in comparison to the efforts of states like Victoria, NSW and Queensland who take the importance of the breeding industry in their state very seriously and produce a significant amount of supporting material, as well as financial support.

# 13 WASBA RAFFLE AND STALLION TENDER

Although it required a lot of work, it did serve a good purpose in providing opportunity for breeders and raised awareness of the breeding season

# 14 STATUS OF HRA MICROCHIP APP

RISE is conducting testing with several brands of Bluetooth enabled microchip scanners that will work with HarnessWeb, and hopes to have a variety of compatible options identified in coming months. These Bluetooth enabled devices will be able to communicate directly with the mobile version of HarnessWeb via a smart phone or tablet device. Microchip scanners are only capable of providing the number on screen, which can then be manually entered into HarnessWeb or HRA's horse search option.

#### General Business

#### 1. HRCG November meeting - Funding Initiatives

J Diederich referred to the initiatives that had been agreed to at the early June Committee meeting.

These initiatives included the previously advised Broodmare Bonus, cash incentive on a live foal, breeder bonus increase, Epona increase, aged Westbred win bonus, Westbred Bonus promotion, and an increased ability of country clubs to create their own mini features.

In view of the material being discussed, a representative of WASBA will attend the HRCG meeting.

#### 2. WASBA AGM

J Diederich advised that the 2021 AGM was held Friday 26<sup>th</sup> November, with the 2022 AGM required to be held before 30 November. Available dates are 28 October (Navy Cup), 11 (Norms Daughter Classic), 18 (4YO Championship) and 25 November (Mares Classic)

# 3. GLOUCESTER PARK REDEVELOPMENT

J Diederich referred to correspondence received late the previous evening.

WASBA does not have a position on the decision to redevelop or not – this is a decision for the members of Gloucester Park.

All parties must wait until the members of Gloucester Park make their decision. Subsequent to that there will be opportunity for discussion on various aspects.

J Diederich noted that there were many other matters that could be addressed that would have no cost associated and would make a difference to the racing. These items include handicapping, programming, size of fields, racing style. barrier draw, starters on each line, These items should all be raised for discussion and resolved before there is any effort to make changes to physical infrastructure.

# ATTACHMENT TO THE MINUTES 7 September 2022 SUMMARY - WASBA FUNDING PRIORITIES

WASBA initiated and fully supported the funding proposals put forward by RWWA in May 2022, but notes the significant delay in implementation considering the benefits were developed from a review that was intended to commence in 2017, and was presented to the Board in 2019. There was an expectation that the options identified would be implemented in 2020.

The proposals put forward by RWWA include timely increases to the Westbred Bonus payments, and commencement of a first starter payment additional to the current first win (both very positive moves that should see an increase in starters. The first starter payment must only apply to WA bred horses.

RWWA is yet to confirm commencement dates for the first starter payment and the Westbred Bonus increases. They are considering bringing the dates forward if the budget can accommodate this.

The remaining initiatives include:

- Changes to the distribution of the Westbred Bonus to 60% winner, 20% second, 12% third, 8% 4<sup>th</sup> (currently 68/18/9/5) when the Westbred Bonus levels increase.
- Drop the proposed 3<sup>rd</sup> (and lowest) tier of Westbred Bonus when stakes are above \$6,000

Additional funding options:

- 1. <u>Broodmare Bonus</u>. (first raised with MHR Noel Reilly) a successful broodmare bonus voucher system, for those mares that have produced winners suggested level \$500 per winner per season and cumulative. The resulting vouchers are based on the success of a specific mare in producing winners, and are therefore not transferable.
- 2. <u>Cash incentive on a live foal</u>, as per other State Administrations.
- 3. <u>Breeder Bonus increase</u>. to 20% (currently 12.5%).
- 4. <u>Increase the EPONA</u> limit to \$8,000.
- 5. <u>Promotion by RWWA of breeding and the advantages of the Westbred incentives</u>
- 6. <u>Aged Westbred win bonus in races less than \$12,000.</u> Ie Westbred winners 4yo and over to receive a \$250 bonus for a win . Consider in lieu of or in conjunction with stakes inceases.

Incentives that do not require additional funding, (on the basis of unspent money from each years budget, of around \$150,000 to \$250,000):

- 1. Increase the current RWWA "mini features" races to \$11,500.
- 2. Increase the Pearl and Diamond 2yo Heats to \$10,000
- 3. Increase the current Group 1 status Pearl and Diamond to \$150,000
- 4. Increase RWWA component of WASBA races to \$12,000
- Review all country mini feature races including races like the DeCampos (were \$20,000, now \$10,000), the Village Kid Sprint at Northam (was \$20,000) and allow clubs to use unused race money to elevate those races up to their previous levels (eg where there are less races run than initially programmed) OR
- 6. Re- Introduce some feature racing at country meetings which could be accommodated if country clubs were allowed to downgrade a race occasionally to supplement stakes for a mini feature.

We are in the business of supporting more of our local product into racing and continuing to race and subsequent breeding
